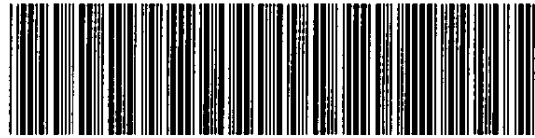

The church general body desires to adopt the new amendments, in place of the old amendments which were made on April 22nd 2007. a) Article VII titled Board of Directors (office bearers) section 1 shall be amended as follows: The church Board of Directors shall consist of the Pastor (President), the Vice President, the Secretary, the Treasurer, and the other elected board member (s). b) Article VII titled Board of Directors section 2 shall be amended as follows: There shall be only one person in the office of Pastor at any time and the Pastor shall be the President of the church. c) Article VII titled Board of Directors section 3 shall be amended as follows: The term of the Pastor in office shall be three years. His term may be extended and the extension and its length shall be decided by a majority vote of the church voting membership in attendance at the annual general body meeting where the extension is discussed. In the event that the Pastor's term is not extended, the Board of Directors shall clear his name from all records of church-related debt and liability including those of lease or of mortgage, before his last day in office.
