The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I: Name

The name of the corporation shall be Fresh Wind International Church, Inc.

ARTICLE II: Principal Office

The principal place of business of the corporation shall be 579 SW Aster Road, Port St. Lucie, Florida 34953.

ARTICLE III: Purpose

The purpose for which the corporation is organized is to create a united body of members who come together to worship God. Fresh Wind International Church is established and empowered by God to love Him and inspire and impact the Body of Christ with the message of God's burning heart of love for His people as the Bride of Christ. The corporation is intended to be a religious not-for-profit organization and will seek tax exempt status from the Internal Revenue Service. The period of this corporation is perpetual unless dissolved according to law.

ARTICLE IV: Manner of Election

The qualifications for members and the manner of their admission will be provided for in the bylaws, which will be adopted at the organizational meeting.

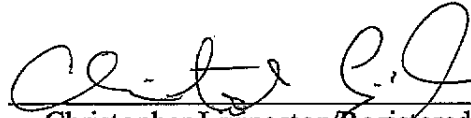

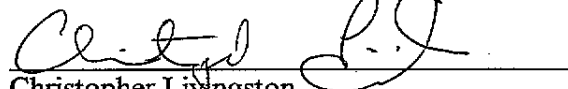

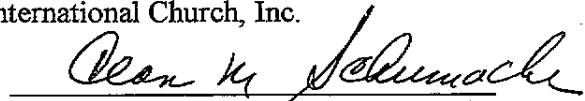
