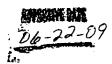

ARTICLES OF DISSOLUTION

Pursuant to section 617.1403, Florida Statutes, this Florida not for profit corporation submits the following Articles of Dissolution:

FIRST: The name of the corporation as currently filed with the Florida Department of State is CARLOS ALBIZU UNIVERSITY FOUNDATION INC. The date that the articles of incorporation were filed is January 16, 2002, and said articles were amended by articles of amendment filed July 30, 2002.

SECOND: The document number of the corporation is N02000000287.

THIRD: The resolution to dissolve the corporation was adopted by joint unanimous written consent of the members and directors (the members and the directors being the same individuals, as provided by the corporation's bylaws), executed in accordance with sections 617.0701 and 617.0821, Florida Statutes, and dated May 2, 2009, which unanimous written consent by the six (6) joint members/directors was sufficient for approval.
