Articles Of Incorporation

of

Pursuant to the Florida Business Corporation Act the undersigned, acting as Incorporator of a corporation, hereby adopts the following Articles Of Incorporation for such Corporation:

Article I Name

The name of the Corporation is The Wharton School Club of Central Florida, Inc.

Article II Corporate Existence

The Corporation's existence shall be perpetual and shall be effective on January 10, 2002.

Article III Registered Agent And Office
