**ARTICLES OF INCORPORATION  
OF  
WORD OF LIFE KINGDOM CHURCH, INC.**

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a Non-Profit Corporation pursuant to Chapter 617.0202, Florida Statutes (F.S.) adopt the following Articles of Incorporation.

- ARTICLE I:** The name of the corporation is Word of Life Kingdom Church, Inc.
- ARTICLE II:** The principle place of business and mailing address is:  
Word of Life Kingdom Church  
5399 Pine Terrace  
Plantation, Florida 33317-1318
- ARTICLE III:** The purpose or purposes for which the corporation is organized is to establish and maintain a place of worship for one true God, to exalt the Lord Jesus Christ and to honor at all times the Holy Spirit. In furtherance of the purposed the church shall:
1. Expound the Word of God by teaching and preaching; and scatter the Word of God abroad in accordance with the commission of Christ (Mark 15:15).
  2. Labor for the evangelization of the world; promote the gospel of Christ in the United States of America and elsewhere by all legal and practical means, but especially by missionary evangelistic work, the members thereof acting as a corporate body, either by themselves or, at their discretion, in cooperation with other bodies considered to be of like faith and practice.
  3. Word of Life Kingdom Church shall have the right, power and authority, in connection therewith or incidental thereto, to purchase or acquire by gift, devise, bequest, or otherwise, either directly or through trustees, and so own, hold in trust, use, sell, convey, mortgage, lease or otherwise dispose of any real or personal property located in the State of Florida or in any other part of the world where permitted by law.
  4. Word of Life Kingdom Church shall have the right to engage in and conduct educational, benevolent, and charitable work; to establish and operate schools, homes for the indigent or aged; to publish and sell or otherwise distribute tracts, periodicals and other literature, and conduct a general printing, publishing, and broadcast business in conjunction therewith, all in accordance with the constitution of the church or any regulation which may be hereafter modified or amended.
- ARTICLE IV:** The manner in which the directors are elected or appointed and administration of all business matters of the corporation shall be vested in the Pastor and the Board of Trustees. The office of president will be filled on a permanent basis by the senior pastor. The senior pastor shall have general oversight and supervision of the church and all of its departments, conduct its services and preside at all business sessions of the church and corporation. The corporate powers, business and

property of the corporation shall be exercised, conducted and controlled by the Pastor and the Board of Trustees for the purposes of the church as set forth in its Articles and Bylaws. They shall have the power to make, amend and repeal Articles and Bylaws to govern the secular affairs of the church. The Board of Trustees shall be appointed by the Pastor and consist of a minimum of five (5) but no more than seven (7) members. Further, all members of the Board of Trustees shall consist of scripturally qualified persons:

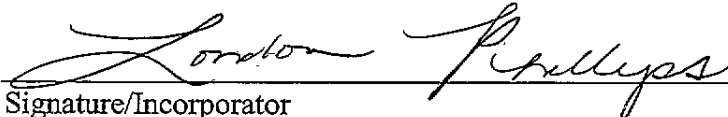

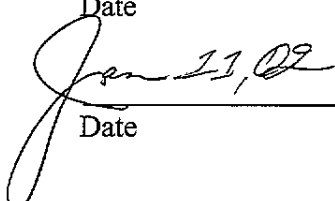
