AMENDMENT TO ARTICLE SIX OF ARTICLES OF INCORPORATION FOR PENNY DUTEAU SCHOLARSHIP FUND INC..

Article six: DISSOLUTION OF THE CORPORATION

Upon dissolution of the Penny Duteau Scholarship Fund., Inc. assets shall be distributed first to the US FAMILY FOUNDATION, in the event the US FAMILY FOUNDATION can not accept the funds then to HOSPICE OF CITRUS COUNTY for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax codes, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated for such purposes.
