**ARTICLES OF INCORPORATION FOR
CENTER FOR THE STUDY OF SENIOR SERVICES, INC.**

The undersigned incorporator hereby incorporates this not-for-profit corporation under Chapter 617 of the laws of the State of Florida, for the purposes contained herein.

I

NAME: The name of this corporation shall be the "CENTER FOR THE STUDY OF SENIOR SERVICES, INC."

II

ADDRESSES: The street address of the initial principal office of the corporation shall be 3206 East Lakeshore Drive, Tallahassee, FL 32312, and the mailing address for the corporation is P.O. Box 15682, Tallahassee, Florida 32317.

III

PURPOSE: The corporation is organized exclusively for charitable, religious, educational and scientific purposes including all purposes authorized under chapter 617, Florida Statutes (1993), and including but not limited to the following purposes: to provide a support and networking group for senior citizens, to offer senior citizens practical and non-legal advice and information including newsletters, to communicate with government officials on issues pertinent to seniors, to provide seniors with the benefits of scientific study on issues related to mental health of senior citizens, particularly on matters of stress, to study the availability and effectiveness of services for senior citizens related to stress, and to take all other lawful actions to represent the interests of senior citizens in the state of Florida and the United States.

IV

ELECTION OF DIRECTORS: The directors of the corporation shall be elected or appointed as set forth in the By-Laws. The initial directors of the corporation shall be: Michael P. McGee, 3206 E. Lakeshore Drive, Tallahassee, FL 32312; Karen M. DeMeester, 275 John Knox Road, E104, Tallahassee, FL 32303; and John Michael Miller, 1308 Cherry Street, Tallahassee, FL 32303.

V

LIMITATION ON CORPORATE POWERS: The corporation shall not be authorized to conduct any activity or take any action that will result in the corporation losing its status as a not-for-profit corporation under the laws of the state of Florida or any exemptions or special tax treatments

under the laws of the United States of America, including but not limited to the United States Internal Revenue Code, if and when exempt status is applied for and granted. It is the intent of the organizers of the corporation to qualify as a section 501(c)(3) tax exempt organization.

VI

REGISTERED OFFICE AND AGENT: The initial registered office of the corporation shall be 1834 Hermitage Blvd., Suite 201, Tallahassee, Florida 32308 and the initial registered agent of the corporation shall be Claire A. Duchemin, 1834 Hermitage Blvd., Suite 201, Tallahassee, Florida 32308.

VI

INCORPORATOR: The name and address of the incorporator of the corporation is: Michael P. McGee, 3206 East Lakeshore Drive, Tallahassee, Florida 32312.

VII

ACTIVITIES AND DISTRIBUTIONS: No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set out above. No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in, (including the publication or distribution of statements) any political campaigns on behalf of or in opposition to any candidate for public office. The corporation shall not carry on any activities prohibited for organizations qualifying and organizing under sections 501(c)(3) or 170(c)(2) of the Internal Revenue Code or any corresponding section of any future tax code.

VIII

DISTRIBUTIONS UPON DISSOLUTION: Upon the dissolution of the corporation, the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose. Any assets not so disposed of shall be distributed by a court of competent jurisdiction in the county in which the principal office of the corporation is located, exclusively for such purposes or to such organizations as the court shall determine, which are organized and operated exclusively for such purposes.
