**ARTICLE OF INCORPORATION**

The undersigned, acting as incorporator of a corporation under the Florida Statutes  
Adopts the following Articles of Incorporation:

**Article I**

The name and address of this Principal Corporation is **MIRACLE DEVELOPMENT, INC.** 1910 Service Rd. Opa Locka, Fl. 33054.

**Article II**

Purpose(s)

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families from a life of Substance Abuse Awareness and Prevention towards a life of self-sufficiency.

**MIRACLE DEVELOPMENT, INC.** is organized for the purpose of providing health and social or support services to those that are in need of HIV/AIDS screening, Counseling, Employment Referral, Child Care Services, and other programs.

**Article III**

The duration of this Corporation shall be perpetual, no stock and shall no members.

**Article IV**

The address of the Registered Office is 1910 Service Rd. Opa Locka, Fl. 33054. The name of the registered agent of the corporation shall be: Carl Speight.

## **Article V**

- (a) This Corporation is organized and operated exclusively for Religious, Charitable and Education purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a Corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a Corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

## **Article VI**

The Directors are elected in accordance with the Bylaws. The name and addresses of the persons appointed to act as the Initial Directors of this Corporation are:

## **Article VII**



### Article VIII

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Religious, Charitable and Education under Section 501© (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal or such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
