- B. To create and provide prison outreach recovery programs that will enable persons, addicted to alcohol, drug abuse and/or other addictive, dysfunctional and compulsive behaviors, to withdraw from these behaviors.
- C. To provide a meeting place where any formerly incarcerated person can come and take part in an outreach program designed to promote Godly self-worth and self-esteem. The programs and teachings are all based upon God's Holy Scripture.
- D. To provide direction and limited learning programs for all members at no cost at all.
- E. To seek and provide referrals to professional Ministers and counselors that can be available for any member of the Ministry at the members discretion.
- F. To ensure the Ministry uphold the values and traditions of a Bible based Organization in the best interest of the public and its members.
- G. The Ministry will be conducted in accordance with current regulations of the United States Government, or the Department of State as may be applicable.

All Directors shall be appointed by the President.

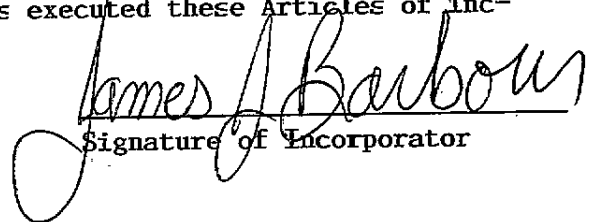

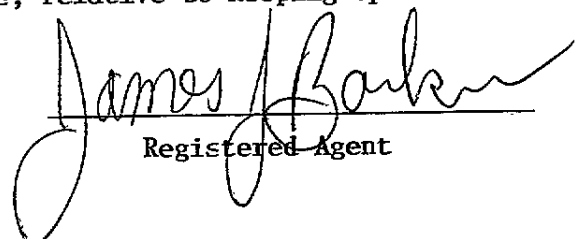
