ONE:

The name and address of this principal corporation is 615 NE 164<sup>th</sup> Street, North Miami Beach, FL 33162, in Dade County. The corporation is organized pursuant to the FLORIDA Non-profit Corporation, Code.

TWO:

This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but **shall not be limited to**: Land Acquisition, Temporary Shelter, Mentoring, Counseling, Temporary Shelter, Clothing, Food Bank, Assistance to Families and other programs to aid those in need.

THREE:

The duration of this corporation shall be perpetual, no stock and shall have no members.

FOUR:
