Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment to its Articles of Incorporation:

# **NEW CORPORATE NAME:**

Otoniel Font Ministries, Inc.

### **AMENDMENTS ADOPTED:**

Article III, Purpose is amended to read –"This organization is organized exclusively for religious, charitable and educational purposes in accordance with section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law."

# Article XVI, Dissolution is added:

(a) Upon the dissolution of the ministry, the Board of Directors shall, after payment of all liabilities of the ministry, dispose of all of the assets of the ministry exclusively for the purposes of the ministry in such manner, or to such organization or organizations organized and operated exclusively for the purposes of the ministry in such manner, or to such organization or organizations organized and operated exclusively for charitable, religious, educational or scientific purposes as shall qualify as an exempt corporation or organization under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law, as the Board of Directors shall determine.

(b) No part of the earnings of the ministry shall inure to the benefit of, or be distributable to, its members, officers, directors or any person except that the ministry shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments in the furtherance of the ministry. Notwithstanding any other provisions of the Articles of Incorporation or the bylaws of the ministry, the ministry shall not carry on any activity not permitted to be carried on (a) by a corporation exempt from Federal Income Tax, under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Revenue Code of the United States of America, or (b) by a corporation, contributions of which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, or the corresponding section of any future United States Internal Revenue Law.

The date of adoption of the amendment was August 6, 2007.

There are no members or members entitled to vote on the amendment. The amendment was adopted by the board of directors.
