**ARTICLES OF INCORPORATION  
OF  
WATER ENHANCEMENT & RESTORATION COALITION, INC.**

*The undersigned incorporator for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I**

**NAME OF CORPORATION**

The name of the corporation shall be " Water Enhancement & Restoration Coalition, Inc."

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of Water Enhancement & Restoration Coalition, Inc., hereinafter entitled the "Corporation", shall be 1520 Royal Palm Square Boulevard, Suite 160, Fort Myers, Florida 33919.

**ARTICLE III**

**PURPOSE**

This corporation is organized for the purpose of enhancing water quality in Southwest Florida. 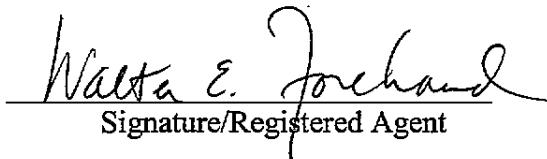
