- ONE:** The name and address of this corporation is Project Future, Inc. Located at 602 South Park Ave, Avon Park, Florida 33825, Highlands County. The registered agent of this corporation is Collis Fogle. This corporation is pursuant of the Nonprofit Code.
- TWO:** This corporation is a nonprofit public corporation organization under the law of the state of Florida. The corporation is not organized for the private gain of any person. The corporation is organized under the Non-Profit Public Benefit Corporation Laws for Charitable and Educational purposes. Land Acquisition, Youth at Risk, Group Home, Transitional Living, Job Training/ Job Placement, Computer Training, Scholarship Program. This corporation is organized and operated Exclusively for the Educational and Charitable Entities under Section 501©3 of the Internal Revenue Code.
- THREE:** The duration of this corporation shall be perpetual, have no stock and shall have members.


