CORPORATE NAME

The name of this corporation is TIMEOUT TUTORING & MENTORING INC.

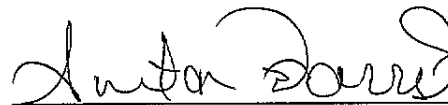
