### ARTICLES OF INCORPORATION OF

Fathersday DC, Inc.

#### ARTICLE I. NAME

The name of the corporation is Fathersday DC, Inc.

ARTICLE II. Principal office.

The address of the principal office and the mailing address of the corporation shall be:

1707 Bayou Grande Blvd. NE St. Petersburg, Florida 33703

## ARTICLE III. Corporate purposes

The corporation is organized and operated for charitable and educational purposes within the meaning of Section 501 (C)(3) of the Internal Revenue code of 1986 or the corresponding provisions of any future United States Internal Revenue Law. Specifically, the purposes of this organization is:

- A. To support a National Father's Day rally in Washington DC and to promote public awareness of the problems of fatherless children in America today.
- B. To educate Fathers, Mothers, custodians and the public on Marriage, Divorce, and Parental Issues.
- C. To educate teenagers and those with potential to become fathers or parents on the seriousness and responsibilities that go with parenthood.
- D. Educate social workers, court officials, and others involved in custody or child abuse cases on the severe and permanent harmful effects on children of Parental Alienation Syndrome, a form of



emotional and psychological abuse, and on other issues concerning, children, fathers and fairness.

- E. To promote joint custody and out-of court settlements when this is in the best interest of the children and all parties concerned.
- F. Notwithstanding any other provisions of these article, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- G. Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE IV. Manner of elections.

- A. Board Elections. Election of new directors or election of current directors to a second term will occur as the first item of business at the annual meeting of the corporation. Directors will be elected by a majority vote of the current directors.
- B. Terms. All Board members shall serve two (2) year terms, but are eligible for re-election.
- C. Quorum. A quorum must be attended by at least sixty-six (66) percent of the Board members before business can be transacted or motions made or passed.
