# Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

## Article I      Name

The name of the corporation shall be: Harborage Ministries, Inc

## Article II      Principal Office

The principal place of business shall be 514 South Eleventh Street Quincy, Florida. The mailing address of the corporation shall be P.O. Box 1735 Quincy, Florida 32353-1735.

## Article III      Purpose

The specific purposes for which the corporation is organized are as follows:

1. To be a non-profit corporation prescribed by Section 501(c)(3) and subsequent amendments, of the Internal Revenue Code, United States of America.
2. To conduct religious, missionary and educational services and activities and projects for Christian ministry.
3. To direct, supervise, oversee, protect, and preserve the fiscal matters and affairs of Harborage Ministries, Inc.
4. To invest in the Board of Directors, referred to in the By-laws, sufficient power and authority in all fiscal matters as well as all property rights of Harborage Ministries, Inc., so that said Board may have as the representative of the aforesaid corporation competent legal authority to represent it, and shall have competent legal representation in all matters and things wherein the property rights and other interests of the aforesaid corporation should be protected and guarded.
5. To engage in any other lawful purpose for which funds will promote the furtherance of the Christian Ministires.

## Article IV      Manner of Election

The directors shall be elected according to the By-laws of the corporation.

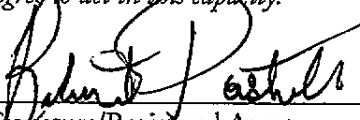

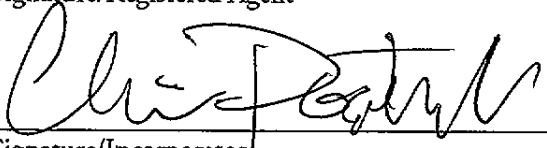
