



The amendments on the last page are in compliance with the IRS needs to grant us the tax-exempt status.





This organization is organized exclusively for charitable and educational purposes within the meaning of section 501©3 of the internal revenue code.

No part of the net earnings of the Corporation shall inure to the benefit of any director, Officer, of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

No substantial part of the activities of the corporation shall be carrying on the propaganda, or otherwise attempting to influence legislation (except as otherwise provided by section 501(h) of the code), and the organization shall not participate in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the organization can not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) 3 of the internal revenue code 1986(or the corresponding provision of any future United State Internal Revenue law or b) by an organization whose contributes to which are deductible under section 170(c) 2 of the Internal Revenue code of 1986(or corresponding provision of any United State Internal Revenue Law).

Upon the dissolution of this organization assets shall be distributed for one or more exempt purposes within the meaning of section 501©3 of the internal revenue code (or corresponding section of any future tax code) or shall be distributed to the federal government or to a state or local government, for public purposes. Any such assets not so disposed of shall be disposed by the court of common pleas of the county in which the principle office of the organization is then located, exclusively for such purpose or to organized and operating exclusively for such purposes.
