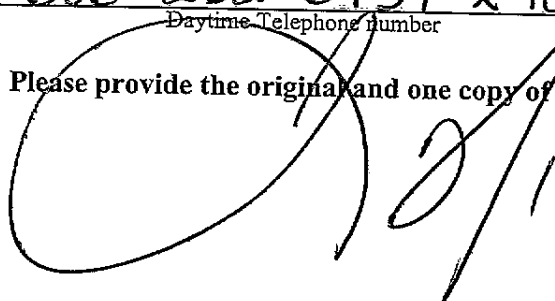

ARTICLES OF INCORPORATION
OF
AGAPE BIBLE CHURCH INTERNATIONAL, INC.

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Agape Bible Church International, Inc.

ARTICLE II PRINCIPAL OFFICE

The initial principal office of the corporation shall be located at:

920 ½ South Ridgewood Avenue #3
Daytona Beach, FL 32114

The mailing address of the corporation shall be:

ARTICLE III PURPOSES

Said corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. The specific purposes of the corporation are:

1. To form and operate a base for teaching ministries which shall be known as Alive Unto God, Agape Bible Church and such other names as may be named;
2. To form and operate a non-denominational Christian faith church or churches, initially in Daytona Beach which shall be known as Agape Bible Church International;
3. To form and operate a Bible school for the purpose of biblical and ministerial training which shall be known as Agape School of the Spirit;
4. To form and operate a music publishing ministry and recording studio for the purpose of publishing, recording and distributing Christian praise and worship music, which shall be known as Gold 'N' Light Music;

5. To give to persons in need, in our church body, in the community and elsewhere, in obedience to the biblical admonition to give to the poor and to help your brother in need;
6. and any other related activities which may be embarked upon.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

1. Appointment
Initial directors shall be appointed by the incorporator.
2. Length of Office
A director may be appointed as a temporary director with length of office specified at appointment, or
A director may be appointed as a permanent director who shall serve until resignation, removal from office or death.
3. Removal From Office
A director may be removed from office due to moral failure and upon the affirmative vote of the remaining directors that such removal is in the best interest of the corporation.
4. Resignation
Any director may resign at any time by giving written notice to any other director.
5. Vacancy on the Board
A vacancy on the board shall be filled by an appointment, subject to the affirmative vote of the remaining directors, or by the sole remaining director.
