ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Old Paths Ministries, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

18295 SW 57th Place, Dunnellon, FL 34432

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- A. Establishment of a Church(s), gatherings/assemblies based upon acceptance of a recognized creed and belief and support of the Church.
- B. Spread the Word of the Gospel through seminars, radio, television, establishment of Church literature, and other forms of mass media for the purpose of educating the individual in the Word of God.
- C. Establishment of religious Schools for Christians and education instruction to the young and old.
- D. Establishment of a Bible Training School or School of Theology (not considered secondary educational institutions) for the preparation of ministers who minister to/for: Old Paths Ministries, Incorporated.
- E. To acquire and hold such property, either real or personal, for Church purposes, as may be necessary for its gathering/assembly and the worship of God.
- F. To acquire, own, lease, mortgage and dispose of property, both real and personal, as may be necessary.
- G. To receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work.
- H. To raise and assist in raising funds for the purposes herein set forth, including the issuance of bonds or other instruments of credit.
- I. To conduct and carry on religious services and instruction through the public media, including electronic broadcasting, AM and FM radio, telecasting, microwave distribution, closed circuit transmission, cable television and the world wide internet.
- J. To acquire, own and operate such broadcasting and/or telecasting facilities.
- K. To accept property and donations in trust for religious or charitable purposes.

ARTICLE IV Manner of Election
