**ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: Dan Joanides Scholarship Trust Fund, Inc..

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are): To raise funds for a scholarship for underprivileged children who are financially challenged and would like to attend college.

The property of this corporation is irrevocably dedicated to the charitable purpose and no part of the net income or assets of this organization shall ever insure to the benefit of any private person. Upon dissolution of the organization, assets shall be distributed for one or more exempt purpose within the meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding section fo any future federal code, or shall be distributed to the Federal, State or local government for public purposes.

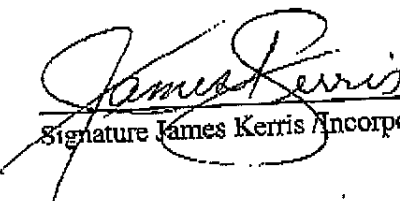
