**ARTICLES OF INCORPORATION  
FOR  
COMMUNITIES IN SCHOOLS OF JEFFERSON COUNTY, INC.**

**The undersigned acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following articles of incorporation:**

**ARTICLE I**

**The name of the corporation shall be Communities In Schools of Jefferson County, Inc.**

**ARTICLE II**

**The address of the principal place of business is 68 Barnhart Road, Monticello, Florida, 32344 and the mailing address of the corporation is the same.**

**ARTICLE III**

**The corporation is formed exclusively for purpose for which a non-profit corporation may be formed under the laws of the state of Florida, and not for pecuniary profit or financial gain. No part of the assets, income or profit of the corporation shall be distributable to, or inure to the benefit of its members, directors or officers except to the extent permitted under Chapter 617 of the Florida Statutes. Further, the specific purpose for which this corporation is organized is to coordinate human services and deliver to at-risk youth in the Jefferson County community and to their families through the supported environment of the public schools or alternative sites.**

**The corporation will endeavor to enable- said youth and their families to have access to a broad range of needed social and educational services by establishing a coordinated delivery system of resources within an educational setting. The objective of the corporation will be to reduce the number of school dropouts in the Jefferson County community.**

**ARTICLE IV**

**The manner in which the directors are to be elected or appointed shall be stated in the Bylaws.**

**ARTICLE V**

**The corporation shall have all the powers presently conferred upon a corporation not for profit by Chapter 617, Florida Statutes.**

**ARTICLES VI**

The street address of the initial registered office of the corporation is 68 Barnhart Road, Monticello, Florida, 32344, and the name of the initial registered agent of the corporation at that address is Willard B. Barnhart.

#### ARTICLE VIII

The assets and income of this non-profit corporation shall be utilized to promote its purposes. No salary or fees shall be paid to the directors or officers of this corporation, but nothing herein shall prevent the hiring of employees or engaging others to perform services for the corporation or to prevent the reimbursement of any persons who make outlays for the reasonable expenses of the corporation.

#### ARTICLE IX


In the event of dissolution the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501 c 3 and 170 c (2) of the Internal Revenue Code of 1954, or corresponding sections of any future Internal Revenue Code, or to the federal, state or local government for exclusive public purposes.
