We, the undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate ourselves together for the purpose of constituting a non-profit Christian music and teaching ministry, to operate in accordance with the Laws of God and in a non-profit corporate form pursuant to the applicable provisions of the Statutes of the State of Florida relative to corporations not for profit, and Section 501©(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law and we hereby Covenant and agree as follows:

Article I – Name

The name of this corporation is: Why Calvary? Ministries, Inc.

Article II – Principle Office

The principal place of business and mailing address of the corporation shall be 11573 Kelvyn Grove Place, Jacksonville, Florida 32225 or at such other place as the directors may decide.

Article III – Purpose

The objectives and purposes for which this corporation is constituted and organized are:

1. To establish and maintain a Christian music and teaching ministry, which will provide Christian teaching and music in church, camp, conference and concert settings. It will also provide training in the areas of music, youth leadership, and the Gospel.
2. To operate such a music and teaching ministry within the State of Florida and other places within the United States, which from time-to-time may be determined by the directors of this corporation. The ministry is to be known as Why Calvary? Ministries, Inc.
3. The ministry will be established to provide churches and organizations with a resource for providing contemporary music, teaching and training. The ministry will work hand in hand with established organizations to enrich the community through positive, morally rich, spoken word and song.
4. To engage in such other businesses, whether related thereto or not, as may be approved by the directors and which businesses are permitted by law.

#### Article IV – Manner of Election of Directors


The manner in which the directors are appointed is specified in the bylaws of the corporation and will always consist of three or more individuals in compliance with Sec. 617.0803, Florida Statutes. Directors are voting members and shall have the sole voting power. The number of directors may be increased or decreased from time-to-time by amendment to, or in the manner provided in the bylaws. Each director shall hold office for the term to which he or she is appointed and until his or her successor has been appointed and qualified or until resignation, removal from office or death. Any majority of the remaining directors even though the remaining directors constitute less than a quorum or by the sole remaining director.

#### Article V – Initial Registered Agent and Street Address


