**ARTICLES OF INCORPORATION
OF
FLORIDA CANCER RESEARCH SOCIETY INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **FLORIDA CANCER RESEARCH SOCIETY INC.**

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: Solicit funds for cancer research

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
