To Whom It May Concern:

This letter is in response to the letter, dated May 7, 2003, that we received regarding our annual report/uniform business report and our check totaling \$61.25 stating that our report had not been filed and was being returned for corrections. The letter you sent requested that we place either the letter "D" or "T" beside the names and business addresses of each director or trustee since Florida nonprofit corporations are required to have at least 3 directors or trustees.

On August 20, 2003, I called and spoke with a examiner named Ruby since we had not received the letter until after August 1 and also to question the request for corrections since we had not been required, on the previous year's report to have either directors or trustees.

To confirm my conversation on that date with Ruby, I am including the following information that we discussed. First, because the officers change yearly, all mail for the group is delivered to Lake City Middle School so that the information is not misplaced. Because of this, any information sent during the summer is not received by the group until the first of August. I was assured by Ruby that because we were a non-profit organization that the late fee/reinstatement fee would not apply even though we had not received the letter asking for corrections until after the 30-day turn-around for return of information had passed. Secondly, Ruby told me that at the time our report was received, that the requirement for 3 directors/trustees was in effect, but that since that time that requirement had been dropped. Therefore, she stated, we had no need to mark any directors/trustees and could just return the letter and the report with no corrections, no additional information, and no additional monies required.

Please find enclosed a copy of the letter that you sent us and a copy of the original annual report that we had sent to you.

Should you need to speak to any of us or should any of the information that I was given or that I have included be erroneous, please contact our organization as soon as possible. All of us involved are merely parents trying to help the soccer program at Lake City Middle School and have no prior experience with running a corporation. It is our
