The specific purpose for which this corporation is organized is: MINISTRIES AND ANY LEGAL BUSINESS.

- Said organization is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501 (c) (3) of the code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
