ARTICLES OF INCORPORATION

OF

The undersigned, being natural person over eighteen years of age, acting as incorporator pursuant to Chapter 617, Article 1396-3.02 of the Florida Non-Profit Corporation Act, adopt the following Articles of Incorporation of such Corporation.

ARTICLE I
