ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LION'S SHARE MINISTRIES, INC., A NOT-FOR-PROFIT CORPORATION

Pursuant to Section 617.1006, Florida Statutes, LION'S SHARE MINISTRIES, INC. adopts the following Articles Of Amendment to its Articles Of Incorporation:

Article VII A is amended to read as follows:

Directors, Officers and Meetings
