I had a Chruch charter in the name of the Storehouse Mission Chruch Inc.
in Tampa Fl. Doc# 767671

I was appoinded director of the Christ Outreach Mission Storehouse Inc.
And Inc. paper were filed on Feb 5, 2002. Doc. # 2000000981 8678 Weast 90
Defuniak Springs, Fl. 32433.

I resigned this appointmentship on June 7, 2002 after being told I could
not keep the two people that had been taken in whan we were open only one day.
