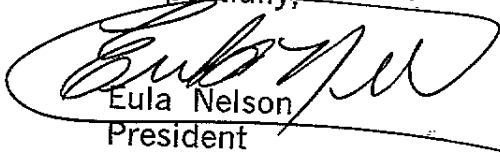

**ARTICLE 1 - NAME**

The Name of this Corporation is: **Nathan Smith Ministries, Inc.**

The principal place of business is: **1713 N.W. 38<sup>th</sup> Avenue, Ft. Lauderdale, FL 33311**  
The mailing address is: **4856 N.W. 1<sup>st</sup> Street, Plantation, FL 33313**

**ARTICLE 2 - PURPOSE/s**

The purpose/s for which this Corporation is organized are exclusively religious, charitable, literal and educational, within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986.

This organization is a not for profit corporation and is not organized for the private gain of any person. It is organized under the nonprofit Public Benefit Corporation Law for charitable purposes.

**ARTICLE 3 - SPECIFIC PURPOSES**

The specific purposes of this corporation are to conduct National and International crusades, for the purpose of spreading the gospel through teaching, preaching and correspondence literature.

To conduct family and marriage counseling, organize workshops and seminars promoting family values and commitments. Establish educational programs stressing preventive measures for abuse within the family.
