The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation

ARTICLE I
NAME

The name of this corporation shall be: Full Gospel Church of God in Christ, Inc.

ARTICLE II
Principle place of business and mailing address
The principle place of business of this corporation shall be:

ARTICLE III
Purpose

The purpose for which the corporation is organized are:
To provide the means, facilities, services and all other activity necessary for providing the worship of God by the members of this corporation (church).

ARTICLE IV
Manner of election of Officers

The manner in which the Officers are elected or appointed is as follows:
The Pastor has all executive powers. The Pastor appoints a Board of Trustees, which is responsible for the execution of the purpose of this corporation both administrative and financial.
All other corporation officers are elected by members of the corporation.

ARTICLE V
Limitation of Corporate power

The provisions of this charter may be modified, altered or amended by a two-thirds(2/3) majority vote of all members of the Board of Trustees. As soon as the proposed alterations or amendments shall have been adopted as herein provided, the result of the vote shall be announced by the Secretary and declared adopted by the Pastor, and filed with the Secretary of the State of Florida, where upon such alterations or amendments shall be full force and effect.

ARTICLE VI

Initial registered agent and street address

The registered agent shall be Herold W. Reaves , Pastor and the initial registered office of the corporation shall be located at:

ARTICLE VII

Property Dissolution

If and in the event Full Gospel Church of God in Christ, Inc. is dissolved, its property, real and personal, shall pass to the Pastor and his appointed Board of Trustees, who have legal right to convey title, shall execute a deed of conveyance where in the legal title to said property shall be vested in the Pastor and Board of Trustees, in Trust for the use and benefit of the members of the Full Gospel Church of God in Christ.






