ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **KEEPERS OF THE FLAME MINISTRIES, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 1880 N. Crystal Lake Drive, #55, Lakeland, FL 33801.

ARTICLE III: PURPOSE

The purpose of this non profit corporation is to establish a religious body constituting a church for the performance of sacerdotal functions and to administer ordinances of sacraments according to prescribed tenets and principals, for the worship of God.

To establish missionary work to offer services to the disadvantaged, both in the United States of America and in foreign countries

To train ministers and missionaries and to ordain qualifying persons for ministry in accordance with these Articles of Incorporation

To establish and operate branch churches and congregations, missions, and facilities useful to the dissemination of the Gospel of Jesus Christ

To conduct these operations in the United States of America and foreign nations

To appoint ministers to serve as pastors at such churches or missions as are established by the corporation

To appoint workers to conduct the work and programs of the corporations


