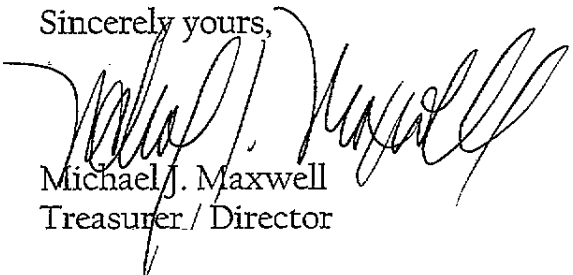

The undersigned incorporator hereby forms a corporation under Chapter 617.02 of the laws of the State of Florida (Not for Profit).

**ARTICLE I. NAME**

The name of the not for profit corporation shall be:

**THE UNIVERSITY OF VIRGINIA SOUTH FLORIDA CLUB, INC.**

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III PURPOSE**

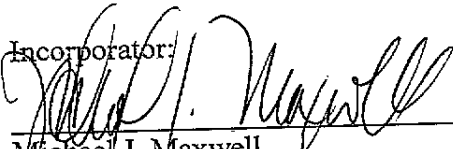

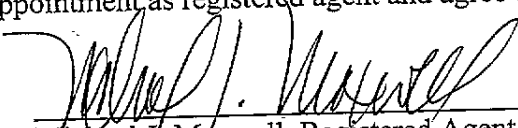

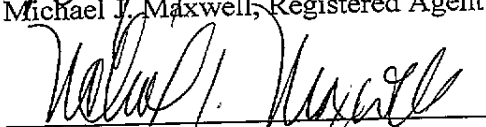
