

In compliance with the requirements of the Laws of the State of Florida, and for the purpose of forming a corporation not for profit, the undersigned does hereby acknowledge:

#### Article I -Name

Name of the Corporation. The name of the corporation shall be: Pasco County Sheriff's Law Enforcement Citizen Academy Alumni Association, Inc ("Association").

#### Article II -Principal Office

The principal place of business and mailing address of this corporation shall be: Pasco County Sheriff's Office, 8700 Citizens Drive, New Port Richey, Fl. 34654

#### Article III - Purpose

The purpose for which the corporation is organized is: To expose graduates of the Pasco County Sheriff's Law Enforcement Citizen Academy with a continuing series of learning experiences thru programs and activities relative to Pasco County, and to provide volunteer services that will enhance the Sheriff's ability to serve the county.

#### Article IV - Membership
