

ARTICLES OF INCORPORATION  
OF  
GULF STREAM R/C CAR CLUB, INC.,  
A Corporation Not For Profit

We, the undersigned, with other persons being desirous of forming a corporation not for profit, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of the corporation shall be: GULF STREAM R/C CAR CLUB, INC.

The principal place of business of this corporation shall be: 330 Old School Road, Gulf Stream, Florida 33483.

ARTICLE II

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to organize, oversee and promote for the recreational and educational enjoyment of its members the hobby of motorized radio-control models.

ARTICLE III

The membership of this corporation shall constitute all persons hereinafter named as officers and directors and such other persons as from time to time may become members by application and approval by the Board of Directors.

ARTICLE IV

The name and address of the subscriber to these Articles is: Richard T. Tripp, 330 Old School Road, Gulf Stream, Florida 33483.

ARTICLE V

This corporation is to exist perpetually.

#### ARTICLE VI

The business of this corporation shall be managed by a Board of Directors. This corporation shall have four (4) Directors initially. The number of directors may be increased from time to time by the Bylaws, but shall never be less than three (3).

The Board of Directors shall be appointed and hold office in accordance with the Bylaws.

#### ARTICLE VII

The Board of Directors of this corporation may provide such Bylaws for the conduct of its business and the carrying out of its purposes as they may deem necessary from time to time.

Upon proper notice, the Bylaws may be amended, altered or rescinded by two-thirds (2/3) vote of the active, privileged and senior members present at any meeting of the membership.

#### ARTICLE VIII

These Articles of Incorporation may be amended by two-thirds (2/3) vote of the Board of Directors.

#### ARTICLE IX

The street address of the initial registered office of this corporation shall be 330 Old School Road, Gulf Stream, Florida 33483, and the name of the initial registered agent of the corporation at that address is Richard T. Tripp. The mailing address is the same.
