Preamble

We, the undersigned incorporators of the Defender of the Faith Ministries, Unorthodox Ministry of Yeshua Inc. mindful of our sacred purpose in the Gospel, in order that this body may be governed in an orderly manner, consistent with the principles of a self-governing body, inherent rights of the individual and the Articles of Incorporation, do declare and establish this constitution. Notice is hereby given that the undersigned incorporators are U.S. citizens of full age, having voluntarily associated themselves for the purpose of forming a not-for-profit corporation without capital stock in accordance under the laws of the State of Florida under the provision of chapter 617, providing for the formation, liability, rights, privileges, and immunities of a not-for-profit corporation.

Article II
Name and Legal Status

This corporation shall be known as Defender of the Faith Ministries Unorthodox Ministry of Yeshua, Inc.

Article III
Principle Place of Business and Mailing Address

The principle place of business of this corporation is 1960 Evergreen Avenue, Jacksonville, Florida, 32206. The mailing address of this corporation shall be 615 Quail Lane MacClenny, Florida 32063.

Article IV
Mission and Purpose

The Defender of the Faith Ministry Unorthodox Ministry of Yeshua, Inc., is a Not-for-Profit Christ-centered, family-oriented church in the center of our community. Our mission is to minister Salvation and to teach and preach the Gospel of Our Lord and Savior Yeshua ("Jesus" named pronounced in the original Hebrew tongue) as we worship, promote and nurture spiritual growth. This corporation shall also be established to raise, receive, and maintain a funds of real property, personal property, or both, and to distribute and administer said fund or funds, including any income or interest generated therefrom, exclusively for religious and educational purposes. This church shall be organized and operated exclusively for religious and educational purposes within the meaning of Section 501©3 of the Internal Revenue Code of 1954, as amended, or any superseding section in order to:

1. Minister the Word of God
2. Conduct a regular religious worship service through various forms of ministries.
3. Promote and encourage, through the ministries of the organization, cooperation with other organizations within the community.
4. Spread the Word of God by ministering to all through seminars, radio, television, and other forms of mass media.
5. To conduct local and international church by the direction of the Lord Yeshua and under the leadership of the Holy Spirit in accordance with all the provisions as set forth on the Holy Bible.
6. To maintain local and missionary church facility.
7. To conduct a school for the training of ministries. To license, ordain and qualify ministers for various ministerial duties.
8. To provide Sunday School or any type of school for the religious and educational instruction of the young as well as for adults under the direction ___ of the church

Mission Statement

The mission of this church is to minister Salvation and Biblical principals for practical living in accordance to the Word of God, thereby enabling every believer to live in the abundance of life and optimal Faith through the Blood of Yeshua, (original Old Testament Name of Jesus Pronounced in the Hebrew Tongue.)

Vision Statement

The vision of this ministry is to see the successful establishment of Kingdom Living in the life of God's people and to destroy the works of the Devil.

Article V

Doctrine

Believing in The Only True God and Eternal Godhead, the divine inspiration and authority of the Holy Scriptures by the Holy Spirit, that eternal salvation is offered freely to all believers in the name of Yeshua (Jesus Christ) as Lord and Saviour, the priesthood of the believer, autonomy of the local church and in freedom of and for religion.

Article VI
Church Government and Affiliations

Proceeding under the congregational plan of government and for the mutual advantage in the pooling of organized strength and the sharing of information and purpose, we, the Defender of the Faith Ministry, Unorthodox Ministry of Yeshua Inc. voluntarily fellowship with all religious organizations that share the common beliefs of the Holy Scriptures but shall remain an independent governing body in accordance with the bylaws of our church

Article VII
Duration

The duration of this corporation shall be perpetual.

Article VIII
Membership

Section 1. Eligibility. Any person shall be eligible for membership in the congregation of the Defender of the Faith Ministry Unorthodox of Yeshua Inc. upon application to and approval as provided in the articles and bylaws of this corporation.

Section 2. Duties Any member of this congregation shall maintain faithfulness in all duties and responsibilities essential to Christian living such as regular church attendance and support of the church and its ministries and share in its common vision as defined in the corporate bylaws.

Section 3. Rights. All rights and privileges of the general membership of this body shall be equal as long as the said membership is maintained in accordance with the bylaws of this corporation.

Section 4. Termination of Membership. Termination of membership shall be at the said and written request of any member. Termination of membership may occur also as authorized by the Pastor under the witness of two officers of the church if there is: **(A:** Continual disruption by the member that threatens the continuity and integrity of the church body. **(B:** Failure in compliance with the ministered Word of God and bylaws after three reprimands by the Pastor in the which termination shall be given in a written notice under the witness of two officers of the church. **(C:** The said member exhibits violent and lawless behavior which causes bodily and emotional harm to members and non-members, **(D.** said member misrepresents or performs unauthorized business transactions which violates the bylaws, reputation, and integrity of the church

organization. **E.)** Membership shall be null and void if said member receives membership with other churches while being a member of this church.

Section 5. Transferability. Membership in this corporation is non-transferable.

Article IX **Officers and Election**

This corporation shall consist of a President, Vice-President, Church Clerk/Assistant Clerk, Treasurer, (3)three Trustees and may have additional offices and members in the future. This corporation shall consist of no less than seven (7) persons and persons shall always be active members of this church and shall be elected and maintain office in accordance with the bylaws of this organization. Election into these offices (with the exception of the Presidency) shall be accomplished through a lawful assembly wherein there is a two-thirds, majority ruling in which each office shall be held for a term of 3-year. A member may hold multiple offices as it benefits the efficiency of the corporation With exception of the Presidency and Vice-Presidency). Officers shall be elected on a 3-year term basis.

Voting procedures may be done by Annual meetings, Special meeting, or Notice of meeting. In either case meetings shall take place with a least 5 days prior notice, Pastoral notification and a two-thirds attendance. Any officer who has proven incompetent with exception to the Presidency and Vice-Presidency, shall be reprimanded and if unsatisfactory progress is not made, shall be removed through lawful voting assembly.

President. The Pastor shall always maintain the Presidency for as long as he holds the Pastoral office of this church and in the which his office and position in this corporation cannot be dissolved through election or impeachment. The Pastor may only be removed from the Presidency through decease, physical or mental incapacitation (or both) or verbal and written voluntary vacancy of this office. The final and total decision of all subject matters shall be subject of Presidential Review, concerning all Church business.

Vice-President. The Vice-President shall act in accordance with the bylaws of this corporation in the absence of the President, shall represent this corporation in business matters, shall be the secondary controlling force in the church and shall succeed the President upon his decease or voluntary vacancy unless other wise declined by the officer.

Church Clerk/Assist. Clerk. The Church Clerk/Assistant Clerk shall maintain the minutes to all meetings, keep accurate written accounts of all activity in this organization and witness all documents pertaining to church functions and affiliations, shall have in custody the corporate seal and shall maintain membership in good standing.

Church Business Affairs Representative: The Business Representative shall represent the Church in all investigations, allegations, business meetings concerning any business of the church unless other representation is appointed. All business inquiries shall be directed to the Church Representative.

Treasurer. The treasurer shall maintain all funds of this corporation, maintain written or computerized records of all financial transactions of this organization, shall assist with all recording secretarial duties, shall witness documents approved by the Board of Director concerning monetary transactions and shall maintain faithfulness, confidentiality and discretion concerning all business matters of the church and shall maintain membership in good standing in this local assembly.

Trustees. The trustees of this corporation shall maintain multiple responsibilities as needed by this organization and shall be empowered to operate in any office that is vacated with the exception of the presidency until a replacement is elected.

Article X

Indemnification of Officers and Directors

All officers and directors shall be indemnified by the corporation against all expenses and liabilities including attorney's fees (including appellate proceedings) reasonably incurred in connection with any proceeding or settlement thereof in which they may become involved by reason of holding office. The corporation may purchase insurance on behalf of all offices and directors or arising out of their status as such.

Compensation To Officers and Directors

Any officer or director of this corporation may be reasonably compensated for any services rendered pertinent to the functions of this corporation which shall be established by the Board of Directors and Chair of Financial Affairs.

Article XI

Article XII
Articles, Bylaws and Amendments

The Board of Directors shall adopt and amend articles and by-laws for this Corporation. The By-laws may be amended, altered, or rescinded by the majority vote of the members of this corporation at any annual meeting or any special meeting called for that purpose.

Any such changes in these article and bylaws shall be subject to final approval of the President/ Pastor.

Article XIII
Dissolution

Upon dissolution of this corporation, its assets remaining after the payment, or provision for payment of all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for religious, charitable or educational purposes and which has established its tax-exempt status under Section 501© 3 of the Internal Revenue Code, or corresponding provisions of any subsequent federal tax laws. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in and for the County of Duval in the State of Florida exclusively for such purposes or to such organization or organizations, as the said court shall determine, which are organized and operated for such purposes.





Article XVI

Bylaws

The bylaws of this corporation may be amended, altered, or repealed by the Board of Directors in a lawful assembly with final approval of the Pastor/President.

This constitution may be amended or repealed by two-thirds vote of a present or called business meeting of the church with the Pastor holding final approval, amendment, appeal or veto of any new establishments or changes. The presentation to the church may be from the pulpit or in a setting approved by the Pastor of the church.

Adopted 8th day of February 2002

By-Laws

The following by-laws adopted by the Board of Directors and members of the Defender of the Faith Ministry Unorthodox Ministry of Yeshua Inc. at meeting in the City of Jacksonville, Florida on the 8th Day of February 2002, shall govern the business of the Church except as the same may be from time to time be abridged or amended.

Article I

Name and Doctrine

Section 1. Name. The name of this church shall be Defender of the Faith Ministry, Unorthodox Ministry of Yeshua Inc., shall be based upon and at all times shall be consistent with its creed and beliefs:

A, The Scriptures. The Bible is the inspired Word of God, the product of Holy Men of old who spoke and wrote as they were moved by the Holy Spirit. The new Covenant as recorded in the New Testament, we accept as our infallible guide in matters pertaining to conduct and doctrine (II Tim. 3:16, II Peter 1:21)

B. The Godhead. Our God is One, but manifested in three persons- the Father, The Son, and The Holy Spirit (Philippians 2:6; Mathew 3:16-17). God the Father is greater than all; the Source of the Word (Logos) and the begetter (John 14:28; John 16:28; John 10:30). Jesus is the Son of God, One with the Father, the Word Flesh-covered, the One Begotten of the Father from the beginning (John 1:1; John 1:14; John 10:30). The Holy Spirit proceeds forth from the Father and the Son and is eternal (John 15:26).

C. Man, His Fall and Redemption. Man is a created being, made in the likeness and image of God, but through Adam's Transgression and fall, sin came into the world. "All have sinned and come short of the glory of God." "As it is written, there is none righteous, no not one." Jesus Christ, the Son of God was manifested to undo the works of the devil and gave His life and shed His blood to redeem and restore man back to God (Romans 5:2; 3:23; 3:9-10; 1 John 3:8, Galatians 3:13-14).

D. Salvation. Salvation is the gift of God obtained through sincere repentance, baptism by water, the receiving of the Holy Ghost, compliance with the Word of God and submission to the authorities whom also obey the Word of God.

E. Baptism. Upon confession, repentance, and agreement with the Word of God, the said member will be a candidate for water baptism in Yeshua's Name at a time deemed at the Pastor's discretion in accordance with Act 2:38.

F. Sanctification. The Bible teaches that without Holiness no man can see the Lord. We believe in the doctrine of sanctification as a definite, yet progressive work of grace, commencing at the time of regeneration and continuing unto the consumation of salvation (Heb. 12:14, I Thess. 5:14-20; II Peter 3:18; IICor 3:18; Phillipians 3:12; I Cor. 1:30)

G. Divine Healing. Healing is for the physical ills of the human body and is wrought by the power of God through the prayer of faith and the laying on hands. It is provided for the atonement of Christ and it is the privilege of every believer in the body of Christ today. (Mark 16:18; James 5:14-20; 1 Peter 2:24; Matt. 8:17; Isaiah 53:4-5)

H. Ressurrection Of The Just and the Return of the Lord. The Angel said, "This same Jesus shall so come in like manner." His coming is imminent. When He comes, the dead in Christ shall rise first; then we which are alive and remain shall be caught upm together with them in the clouds, to meet the Lord in the air." (Acts 1; I Thess. 4:16-17)

I. Hell and Eternal Retribution. The one who physically dies in his sins without Christ is hopelessly and eternally lost in the lake of fire and therefore repentance. The lake of fire is literal. The terms "eternal and everlasting" is used in describing the duration of the punishment of the endless existence as used un noting the duration of joy and ectasy of the saints in the presence of God. (Hebrews 9:27; rev. 19:20; Hebrews 6:1-2).

J. Communion-The Lord's Supper. We partake of the Lord's Supper to show the Lord's death til he comes.(1Corinth. 11:23-31). The Bread symbolizes the Lord's broken (Is. 53:5 I Cor. 11:25). The cup represents the new covenant in His blood which provides us forgiveness and relationship with God (Heb 9; I Cor. 11:28-30) for if we receive it unworthily-without giving it honor as our salvation-we are guilty of the body and the blood of the Lord (Cor. 11:27).

K. Laying On Hands. A simple belief that the power of anointing or any other necessary quality can be transmitted from one person touching another practiced it in Mark 10:13-16 as a blessing. Laying on Hands for Healing (Mark 5:25 and 41; Mark 5:28-31; Acts 28:8 Acts 19:11,12); Laying on of Hands to confer office (Acts 6: 2-6); Laying on of Hands to believe words spoken, to laying of hands was practiced by the Levitical Priesthood. Jesus receive the anointing and to cultivate the anointing (I Tim. 4:14); Laying on of Hands for Ordination to consecrate and receive the necessary ministry tools (I Tim. 4:14).

L. Tythe and Offering. The system of giving first spoken of in Abraham and bridges over into the New Testament, in which a tenth of the believer's income is given to the church for the upkeep of the ministry and care of the laborers of Christ. Tything is not optional or considered charitable, but is the obligation of every believer as God has prospered the believer. Tythe is consider the tenth of all income and the freewill offering is left at the discretion of the giver. (Malachi 3:8-12)

M. Five-Fold Ministry. The ecclesiastical government set forth in the Holy Scriptures for the establishment of the ministry and for the perfecting of the entire body of Believers consisting of Apostles, Prophets, Evangelists, Pastors and Teachers.(Ephesians 4:10-15)

N. Greek and Hebrew Bible Study and Word Usage. Historical proof has been uncovered to reveal that the Bible was originally written in Hebrew, Greek and Latin. We believe that to teach and bring understanding in these languages will also give us a clearer understanding of the original texts and meanings contained in the Holy Scriptures.

Article II
General Church Offices

The general church offices/committees of the Defender of the Faith Unorthodox ministry of Yeshua Inc. shall include but not limited to:

The Pastor/Co- Pastor. The Pastor/Co-Pastor shall preach the Word of God, lead the Church in various ministries, seek and win lost souls to Christ and perform such other ministerial duties consistent with the Holy Scriptures in either it's English, Hebrew or Greek form. The Pastor may recommend to the Personnel Committee a suitable candidate to fill any vacancies in the Church staff and supervise the work, assignment of duties and annual evaluation of the Church Staff. The Pastor and the Board of Trustees shall appoint all members and their replacements to the standing committees. The Pastor and staff shall serve as resources and advisors to all boards, committees and organizations of the organization shall desire. The Pastor's shall be filled as set forth in the Article of Incorporation. The Co-Pastor may exercise all Pastoral rights and privileges under the authority of the Senior Pastor or in his absence.

The Deacons/Praying and Elect Women. Shall seek out the individuals in the church who are in need and use the resources of the church for their relief; visit the sick and homebound; distribute the elements of the Lord's Supper; and perform any other service consistent with the origin and duties of the office as described in the Holy Bible and particularly Acts 1 and I Timothy 3. The Deacons/Praying and Elect Women shall also serve as a council of advice and conference with the Pastor, consider and formulate plans for the constant effort and progress of the Church in all things pertaining to the saving of souls, development of the Christians and the extension and growth of the Kingdom of God.

Sunday School Department/Superintendent. Responsible for the organization, curriculum, and coordination of all Sunday School classes such as Adult and Children Studies. Shall be responsible for reporting the spiritual progression of each class and addressing any deficiencies or delinquencies that may affect the growth and integrity in the body of Christ.

Praise and Worship Team. Responsible for the coordination and organization of the Praise and Worship (when call upon) services of this church. Shall be responsible for finding appropriate music and practice time for each session.

Minister of Music. Shall be responsible for the overseeing of all music chosen for any events in this church.

Article III **Standing Committees**

Standing committees shall exist to support, direct, manage and have responsibility for the ongoing programs and functions of the church. The members of all standing committees shall be appointed by the Pastor and the ministers of the Church. Any member may elect to be involved in these committees as long as he/she is found within the guidelines and regulations of the church. There is no service time limit as long as the member is productive and maintains his/her responsibilities in the church. Should the member's performance be found unsatisfactory, the member may be asked to resign their post. New committees may be formed or deleted at any time as deemed necessary:

Finance Committee. The finance committee shall consist of three members. The Treasurer shall always be a member of this committee and the Pastor and Co-Pastor shall give final approval of all financial transactions and fund raising projects of this committee.

This committee shall be responsible for the fiscal affairs fo the Church's budgets, preparation and submission of an annual budget for the Church's financial structure and planning for the financial stability and empowerment of the Church. Shall be responsible for the giving of counsel, assistance and advice for any special or temporary financial programs of the church; the provision of an annual audit of the finances of the church; the overseeing of all expenditures authorized by the budget; and where practical and reasonable, seeking of church approval for expenditures not provided for in the budget. The chair or designee shall present to the Board of Directors at its regular monthly meetings the minutes of the Finance Committee to keep the Directors informed of the fiscal affairs of the church. The Chair or designee shall also give a financial report to the Board at their regular monthly meeting and to the church at regular business meetings.

Pulpit Committee(Armorbearers only) . Responsible for making sure refreshments and any other necessities are available for the Pastor and visiting Ministers. Also responsible for opening the church doors and ensuring continuity of Pastoral Care whether at the home church or away. Assist with Baptisms, Ordination Services and Communion.

Witnessing Committee. Responsible for organizing monthly or weekly teams to go out into the community to compel people to Christ.

Abundant Life Committee. Responsible for encouraging a life of fitness and healthy eating living. Organizing functions that encourage a healthy lifestyle such as AIDS awareness, fitness programs under the instruction of a licensed professional.

Women for Warfare Committee. Responsible for organizing women's functions and outreach ministries to assist women in reaching their optimal potential in Christ, various aspects of ministry, by counseling, prayer and spiritual support.

War Cry Committee. Responsible for organizing Men's functions and outreach ministries to assist men in reaching their optimal potential in Christ and to offer counseling and spiritual support.

Public Relations Committee. Responsible for publicizing the functions of the church and organizing various means of publication via radio, television, flier,ect...

New Member Orientation Committee. Responsible for orientation of new members and answering questions concerning church doctrines and bylaws so that the new member is informed of all aspects of ministry and expectations of this church.

DayCare Committee. Responsible for the care of children during service hours (when available).

Video and Taping Ministry. Responsible for the taping or video of services as deemed by the Pastor.

Ambassadors for Christ Ministry. Responsible for representing the Church at various functions at the request of the Pastor.

Food and Clothing Committee. Responsible for collection and distribution of various foods and clothing for those in need.

Funeral Committee. Responsible for assisting members in their time of grief with spiritual support and assistance with funeral preparation and any necessities needed at that time. Upon financial availability of church funds. Funerals may be held at the church but shall be conducted under spiritually acceptable guidelines. Non-members will be asked to give a offering for the use of facilities and must provide clean-up after services.

Wedding Committee. Any member desiring to use Church facilities may do so at any time with exception to any previously scheduled services. This committee is responsible for ensuring that acceptable guidelines are followed for all wedding ceremonies as becoming holiness in the House of God. All music and activities must be approved by the committee chair before date confirmation. Non-member will be asked to give an offering for use of facilities and provide clean-up services thereafter.

Marital/Divorce Counseling. Any Member desiring to marry/divorce under the Pastor of this church must meet counseling guidelines set at the discretion of the Pastor. A certified copy of Premarital counseling will be given to those who request a copy which shall bear the corporate seal of the Church.

Article IV
License and Ordination
Section 1

Upon satisfactory evidence of the a divine call to the ministry and whose views upon examination prove consistent with the Apostolic Christian Faith in general beliefs in the teachings of the Word of God, Candidates for licensing (Pastorial, Evangelical, Deaconship ect.) shall be presented by the Pastor and ministers this Church and there receive confirmation before the congregation. Upon approval of the Pastor and Ministry, The Man of God or God's Woman shall receive a certificate of License bearing the church corporate seal and ministerial signatures. Upon licensing of the minister and ordination/installation service shall be performed.

Any minister bearing a license from The Defender of the Faith Ministry Unorthodox Ministry of Yeshua Inc. shall maintain activities and engagements under the approval of the Pastor of the Church and should any activities occur without approval and notification to the Pastor, His/Her License shall be revoked and shall not be endorsed after examination of circumstances by the ministry.

Ministers currently holding licensure from another ministry of like faith and scriptural foundation who wish to pursue membership under this ministry shall endure examination by Leadership of this church before ministerial rights are permitted.
