ARTICLE III PURPOSE

The purposes for which the Corporation is formed are: This perpetual corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, to preach, teach, consult, train and develop, evangelize, counsel, assist, and pastor to the laity, communities, and all interested parties in the following key areas:

- Biblical and spiritual Christian Apostolic faith doctrine and teachings
- Mission programs for the relief of the poor, the distressed, or the underprivileged
- Religious educational activities, programs, and/or enterprises
- Christian Apostolic faith religious educational system(s), including the development, use and/or education of any learning materials, any books, and/or any media, and/or any technological applications, computer-related, and/or any innovations necessary to implement and sustain same in a Christian Apostolic faith religious educational system(s), academy(ies), and/or bible institute(s), and/or program(s)
- Other church integrated auxiliaries, and
- All other things that sustain Christian charitable, religious, and educational church programs

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate of public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

After completing all requirements of the Statutes of Florida for Dissolution of the Corporation, and after paying and discharging all the corporate debts and liabilities, distribute the remaining corporate assets and property among the members in the following manners or any combination thereof, including paying any member of the corporation the amount advanced or loaned to the corporation by him or her, together with no interest rate per year. Any remaining assets shall be transferred to any other not-for-profit corporation, organized for the purposes substantially the same as those of this corporation, if the laws, bylaws, or regulations of this corporation so provide, or shall escheat to the State.

ARTICLE III PURPOSE (cont.)

Also, upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
