**ARTICLES OF INCORPORATION
OF
POWER FROM ON HIGH EVANGELISTIC MINISTRIES, INC.
A FLORIDA NON-PROFIT CORPORATION**

Article of incorporation of the undersigned, desiring to form an evangelistic ministry under the Non-Profit Corporation Law of chapter 617, Florida Statutes, do hereby certify:

ARTICLE 1. NAME

The name of the Corporation is **Power From On High Evangelistic Ministries, Inc.**

ARTICLE 2. DURATION

The Duration of the Corporation is Perpetual.

ARTICLE 3. PLACE OF BUSINESS

The principal office of the Corporation is 1125 N.E. 80th Street, # 7, Miami, Florida 33138
The mailing address of the Corporation is 1125 N.E. 80th Street, # 7, Miami, Florida 33138

ARTICLE 4. PURPOSE (S)

The purpose (s) of **Power From On High Evangelistic Ministries, Inc.** is to be an evangelistic ministry organized under Chapter 617, Florida Statutes, exclusively for charity purposes as defined in Internal Revenue Code 501 (c)(3). It is not organized for the private gain of any person.

Section 1.

The purpose of **Power From On High Evangelistic Ministries, Inc.** is to spread the Gospel, encouraging all humanity to persevere through their daily trials and tribulations and to tell them that God loves them no matter where they have been in life and that there is forgiveness and life in Jesus Christ.

Section 2.

The purpose of **Power From On High Evangelistic Ministries, Inc.** is to establish,

- **Adopt- A- Block Outreach Mission:** Each week the ministry will travel to surrounding neighborhoods to sweep sidewalks, remove trash from yards, mowing lawns and cleaning vacant lots.
- **Homeless Outreach Mission:** Several nights a week the ministry will provide food, blankets, flashlights, and clothing to the homeless.
- **Prison Outreach Mission:** When given the opportunity, the ministry will bring **Power From On High Evangelistic Ministry** gift bags into local jails, juvenile delinquent centers, and also conduct services and fellowship with inmates.
- **Mobile Food Van Outreach Mission:** Several times a week, the ministry will travel to different points of the city and deliver food to the poor.
- **Nursing Home Outreach Mission:** Several times a week, the ministry will visit men and women in the inner city convalescent homes to share a message of hope, comfort, and joy through music, singing, and encouragement.
- **Seniors Outreach Mission:** Each week the elderly community will be invited to a luncheon that encourages fellowship and prayer. Transportation will be provided.
- **Special Events Outreach Mission:** Annually Christmas, Easter, and Thanksgiving theatrical plays, and Revivals will be held at the ministry.

Section 3.

The purpose of **Power From On High Evangelistic Ministries, Inc.** is to meet the family spiritual, emotional, and other needs of its member and of the individuals in the community. The ministry will provide the resources with which to reach out into respective communities to provide full range of support ^{to} each individual member in the church and surrounding community needs.

Section 4.

The purpose of **Power From On High Evangelistic Ministries, Inc.** is to provide practical clinically oriented training specifically directed towards healing, health, and restoration to individuals, and the related family members of those whose lives have been effected by marriage and family problems, substance abuse, sexual abuse, perversion, severe emotional problems, and those facing major illness and death.

Section 5.

The purpose of **Power From On High Evangelistic Ministries, Inc.** is to provide the families of the local community, and of the individuals involved in the ministry **Recovery Mission**, with counseling and social services from a Christian perspective. Included in the ministry will be residential and other care facilities and programs.

Section 6.

The purpose of **Power From On High Evangelistic Ministries, Inc.** is to provide residency and outpatient facilities primarily for the treatment of drugs and alcohol dependency and directly related conditions. There will be special programs for the treatment of adults and for adolescents. The ministry will also be directly related to a **Health Care Network** to provide rehabilitative services for the clients. The ministry will also be directly related to the local churches so that the related families may receive the services they need as well.

Section 7.

The purpose of **Power From On High Evangelistic Ministries, Inc.** is organized to establish financial benefit programs for individuals. Included in the programs are * financial counseling, *income tax preparation, *debt counseling, *flexible savings plans, and other economic benefits which may be utilized by individuals, at various levels.

Section 8.

The purpose of **Power From On High Evangelistic Ministries, Inc.** is to establish an endowment through "**Touching Lives**" magazine, to raise funds that will sustain the ministry.

Section 9.

The purpose of **Power From On High Evangelistic Ministry, Inc.** is to engage in any and all lawful business purpose (s) in the United State of America upon non-profit corporations. Is not for a private gain. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered. To make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of the corporation shall be the carrying on of propaganda. Otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Not withstanding any part of these articles.

Section 10.

This Corporation shall not carry on any other activities not permitted to carry on. (A) By a corporation exempt from federal income tax under Section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal income tax code. (B) By a corporation, contributions to which are deductible under Section 170 (C)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE 5. CORPORATION DISSOLUTION

The Corporation Distribution of Assets, upon the dissolution or winding up of this corporation, its assets remaining after payment or provision for payment of all debts and liabilities of the corporation, shall be disposed of by the court of common plans of the county in which the principle office of the corporation is then located, exclusively to religious and charitable purpose organizations, as said court shall determine, which has established its tax exempt status under Section 501(C)(3) and 170 (C)(2) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

ARTICLE 6. INITIAL REGISTERED AGENT AND OFFICE
