ARTICLE I - CORPORATE NAME AND PRINCIPAL ADDRESS

The name of this corporation is Aiki Atlas Foundation, Inc. and the principal address of the corporation is 3652 N. Lincoln, Chicago, IL 60613.

ARTICLE II - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III - PURPOSES FOR WHICH THE CORPORATION IS ORGANIZED

The purposes for which this corporation is formed is to operate for educational and other related purposes as set forth in Section 501 (c)(3) of the Internal Revenue Code. The corporation shall have all powers as provided in Section 617.0302, Florida Statutes (2000) and as subsequently amended unless otherwise prohibited in these Articles of Incorporation or Bylaws.

ARTICLE IV - PROHIBITED TRANSACTIONS

This corporation shall not:

- A. Engage in any activities prohibited by Section 617.0835, Florida Statutes;
- B. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE V - DIRECTORS

The directors of the corporation shall be elected in accordance with the by-laws of the






