## ARTICLES OF INCORPORATION OF ITS THAT EASY, INC.

The undersigned Incorporator, for purposes of forming a corporation pursuant to triangle 617, Florida Statutes, adopt the following Articles of Incorporation:

FIRST: The name of this Corporation is as set forth above.

**SECOND:** The corporations principal place of business and mailing address is 1543 South Highland Avenue Suite 261, Clearwater, Florida 33756.

**THIRD**: The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of Florida. This Corporation shall be a non profit corporation. This corporation is organized exclusively for charitable purposes. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(20 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**SEVENTH:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such

organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

**EIGHTH:** Ricardo Quintana Sr., 1543 South Highland Avenue Suite 261, Clearwater, Florida 33756 is the incorporator of this corporation and shall act as the Registered Agent of this Corporation. The Registered office shall be at the address set forth previously in this paragraph.
