### ARTICLES OF INCORPORATION

Of The Life Center of Hernando In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be The Life Center of Hernando Incorporated.

# ARTICLE II PRINCIPAL OFFICE

The principal mailing address of the corporation shall be: 3443 Minnow Creek Dr. Hernando Beach, FL 34607

# ARTICLE III PURPOSE

The specific purpose of the Life Center of Hernando shall be: To provide faith-based social services, both residential and non-residential in nature to residents of Hernando County and surrounding areas which may include Pasco, Sumter, and Citrus counties.

## ARTICLE IV MANNER OF ELECTION

Directors shall be appointed for a 5-year term initially and may stand for re-election to the board at 5-year intervals there after. Should a director resign from the board prior to the completion of the 5-year term, the board shall, by majority vote, appoint a board member to serve the remainder of the 5-year term. The board shall consist of at least 3 members and not more than 7 members.

## ARTICLE V INITIAL DIRECTORS/OFFICERS

The initial directors of The Life Center of Hernando shall be Barbara Lemoine, Chairperson; James Ballard, and Carolyn Timmons members of the board.

# ARTICLE VI INITIAL REGISTERED AGENT AND STREET ADDRESS

## ARTICLE VIII DISSOLUTION
