ARTICLES OF INCORPORATION OF THE EPISCOPAL CHURCH UNITED, INC.

The undersigned Incorporator, desiring to form a Nonprofit Corporation pursuant to the provisions of the State of Florida, submits these Articles of Incorporation to that end and hereby states as follows:

ARTICLE I.....NAME

The name of this Nonprofit Church Corporation shall be: THE EPISCOPAL CHURCH UNITED, INC.

ARTICLE II.....PRINCIPAL OFFICE

The principal place of business and mailing address shall be:

Spring Hill, Florida 34606

ARTICLE III.....PURPOSE

The objects and purposes for which this Nonprofit Church Corporation is formed are: To follow the Scriptural mandates of Jesus Christ, to love and be servants to all; to evangelize, preach, expound and propagate the Gospel of Jesus Christ in any and all ways and places which are in accord with the Holy Scriptures; to educate and lead the people in the ways of salvation, righteousness, goodness, morality, temperance, and spiritual leadership; the prosecution of works in any Christian missionary, educational or charitable enterprises, including, but not exclusive of the establishment of local churches, broadcasting ministries, schools and training centers, personal counseling ministries, publications, and the affiliating into this universal Church Corporation any previously established local church congregations which embrace its Bible doctrines and bylaws, and which apply the form of Episcopal Church government set forth in the bylaws of The Episcopal Church United, Inc., and further contribute substantially and financially toward the collective works and ministries carried on by The Episcopal Church United, Inc.

The Episcopal Church United, Inc. Shall have the right to possess, buy, mortgage, sell, lease, barter, and exchange real and personal properties, to borrow money, collect funds, receive gifts and legacies as it may judge necessary for the prosecution and attainment of its Scriptural mandated objects and purposes. It shall also have the power to license, ordain and send forth any pastor, evangelist, missionary or preacher who has proven his/her Divine gift and calling of God to the satisfaction of Bible mandates and the undersigned incorporator, along with the Board of Directors.

ARTICLE IV....ADHERENCE TO REVENUE CODES

This Church Corporation shall not carry on any activities not permitted by (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue law) or (b) by a corporation, contributions to which are deductible under the Section 170(c)(2) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue law).

ARTICLE V...MANNER OF ELECTION

The initial Directors, who shall comprise the Board of Directors of The Episcopal Church United, Inc., have been appointed by the Corporation President for a term of one year from the effective date of this Corporation. Thereafter, the Board of Directors itself shall convene an election, at which meeting new or additional Directors may be elected for terms of three years service. In the event it becomes necessary to replace any Director, for any reason, prior to the scheduled convening of the Board of Directors, the Corporation President shall appoint a replacement Director, who shall remain in that position until such time as an election meeting can be convened by the entire Board.

ARTICLE VI...INITIAL DIRECTORS OF BOARD

The initial Directors of The Episcopal Church United, Inc. shall consist of three (3) members.
