ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be:

Joy in the Harvest Ministries, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This corporation shall have perpetual existence and engage in any activity permitted under the laws of the United States and the State of Florida within the following purposes:

- 1. To solicit and receive contributions, and manage the funds received for the establishment and maintenance of a church or churches named or to be named in accord with the acts of the Board of Directors of the Corporation.**
- 2. To establish and maintain domestic and foreign educational and charitable ministries for the furtherance of the religious doctrine and precepts of the church or churches established or to be established under the Corporation.**
- 3. To transact any lawful business for the benefit of the church or churches and ministries under the corporation.**
- 4. This corporation is organized exclusively for religious, educational, charitable and philanthropic purposes, and not for profit; it shall have all of the powers permitted by law.**
- 5. Notwithstanding the foregoing statements of purposes, this corporation shall not, except to an insubstantial degree, engage in any activities that are not in furtherance of the primary, religiously oriented purposes of the corporation, and nothing in the foregoing shall be construed to authorize this corporation to**

carry on or conduct any activity for the direct profit of its members.

6. Upon dissolution of this corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all the assets of the corporation by transfers or conveyances to another organization deemed to be exempt under the provisions of Section 501, Internal Revenue Code of 1954, as amended, or the corresponding provisions of any future United States Internal Revenue Code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

There shall be three Board of Directors initially and the President of the Board will appoint (4) four additional members who will serve a one year term with re-election to additional one year terms approved by the three initial Board of Directors.
