### ARTICLE ONE NAME

The name of the corporation shall be **COMMUNITY ORGANIZATION FOR BRAZILIAN AFFAIRS, INC.** 

### ARTICLE TWO LOCATION

The location of the principal office of the corporation shall be 777 South Federal Highway, # RP417, Pompano Beach, FL 33062.

### ARTICLE THREE PURPOSE

The purpose of the corporation shall be the following:

- 1-To provide community organization, social, mental health, drug addiction prevention, and other related services to the Brazilian community of South Florida.
