ATTACHMENT TO ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PALM BEACH COUNTY FOOLS, INC.

ARTICLE III PURPOSE SHALL BE AMENDED TO READ: This Corporation shall be a nonprofit corporation. The purposes for which PALM BEACH COUNTY FOOLS, INC. is organized are exclusively charitable, educational, and religious within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. The specific purposes of this Corporation are: (a) to provide relief to poor, distressed, and underprivileged persons by fundraising for other charities, providing relief to terminally ill children and child cancer victims, and through other volunteer and charity work, and (b) to educate the public on the history and culture of firefighting and firefighters.

ARTICLE VIII: Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IX: The property of this corporation is irrevocably dedicated to religious, educational and charitable purposes and no part of the net income of assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
