**ARTICLES OF INCORPORATION  
OF

The undersigned, Alan Wozniak, whose address is 4911-C Creekside Drive, Clearwater, Florida, 33760, acts as Incorporator of a Corporation under the Florida Not-For-Profit Corporation Act, Chapter 617, Florida Statutes, and submit the following Articles of Incorporation for such Corporation:

**ARTICLE I - NAME**

The Name of the Corporation shall be Tampa Bay Spirit Basketball, Inc.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this Corporation shall be 4911-C Creekside Drive, Clearwater, Florida, 33760 or such other place as may be designated from time to time by the Board of Trustees of this Corporation.

**ARTICLE III - PURPOSE**

The purpose for which this Corporation is organized is to assist athletes to develop and improve their basketball skills, by providing knowledgeable coaching in a fun and positive Christian environment, and such other lawful reasons as a non-profit organization may incorporate and organize under the laws of the State of Florida.

The Spirit mission is to provide basketball players from Florida with sound basketball coaching and a spiritual emphasis. We desire that our players perform at the highest competitive athletic level, while seeking God daily in their lives.

**ARTICLE IV - MANNER OF ELECTION**

The manner in which the directors are elected or appointed is as follows:

B. On the anniversary of the formation of this Corporation, and annually thereafter, the Board of Directors of the Corporation shall be selected through a vote of the Members of the Organization, as that term is defined in the Bylaws of the Organization.




