Article VIII

A. No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

B. Upon dissolution of the corporation, the board of directors shall, after paying or making provision for payment of the corporation's liabilities, dispose of the corporation's assets exclusively for the purposes of the corporation in such manner and to such organizations that are organized and operated exclusively for charitable, scientific or educational purposes as shall at that time qualify as tax exempt organizations under I.R.C. Section 501(c)(3), as the board of directors may determine.

C. No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, directors, officers or other private persons, except that this corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of the purposes set forth in these articles of incorporation.

Article IX

This corporation shall indemnify any of its officers or directors to the fullest extent permitted by law.

Article X

The sole member of this corporation shall be S.O.C.K. (Save Our Communities and Kids) Youth Foundation, Inc., a Florida nonprofit corporation, the sole purpose of which is to operate for educational, scientific and charitable purposes within the meaning of Internal Revenue Code Section 501(c)(3), as amended.
