## ARTICLES OF INCORPORATION OF TAMPA HISTORICAL AND CULTURAL EDUCATION COMPLEX, INC.

#### **ARTICLE I**

#### Name and Address

The name of this corporation shall be:

#### Tampa Historical and Cultural Education Complex, Inc.

#### ARTICLE II

#### **Purpose and Limitations**

This corporation is formed to carry out a Cultural Educational message to the citizens throughout the state of Florida. Aiming to educate, empower, and unite individuals, families, churches, organizations and communities to provide cultural education to the citizens of our neighborhoods, along with the tourist visiting our city. In so doing, the center will house black artifacts, black art, and a museum of the Negro League of Baseball; The Belmont Heights Little League history including the Four Major League players whence came from the Belmont Heights Little League.

This corporation shall receive and maintain funds of real and/or personal property, and subject to the restriction and limitations hereinafter set forth, shall use the whole or any part of the income there from and the principal thereof exclusively for its charitable and educational purposes.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to any member, trustee or officer of the corporation, or any private individual (except that reasonable compensation maybe paid for services rendered to or for the corporation affecting one or more of its purposes), and no member, trustee or officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.



Not withstanding any other provision of these Articles of Incorporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code of 1954 or the regulations issued thereunder, or by an organization, contributions to which are deductible under Section 170©(2) of such code and regulations issued thereunder.

In the event of dissolution or final liquidation of the corporation, the residual assets of the organization will be distributed to the Cultural Historical and Cultural Education Complex Inc. as per Sections 501 © (3) and 170 © (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior of future Internal Revenue Code, for an exclusive public purpose.

#### <u>ARTICLE III</u>

#### Power and Limitations

This corporation shall have and exercise all powers provided by the laws of the state of Florida pertaining to corporations not for profit including, but not limited to, Chapter 617 Florida Statutes, and future amendments thereto, or succeeding statutes pertaining to corporations not for profit in the State of Florida, that are necessary or convenient to effect any and all of the charitable and educational purposes for which the corporation is organized, subject, however to the following:

- A. This corporation shall be operated exclusive for, and shall only have the power to perform, activities exclusively within the meaning, requirements and effect of Section 501 © (3) of the Internal Revenue Code of 1954, as amended heretofore or hereafter.
- B. This corporation shall not engage in any act of self-dealing as defined in section 4941 (d) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.
- C. This corporation shall not engage in any act of self-dealing as defined in section 4941 (d) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.
- D. This corporation shall distribute its income for each taxable year at such time and in such manner as not to become subject to the tax or undistributed income imposed by Section 4942 of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.

- E. This corporation shall not retain any excess business holdings as defined in Section 4943 © of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.
- F. This corporation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.
- G. This corporation shall not engage in any prohibited transaction as defined in Section 503 (b) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.

#### **ARTICLE IV**

#### <u>Members</u>

The members of this corporation shall consist of those persons who comprise the first Board of Directors of this corporation and such other persons over eighteen (18) years of age of the Board of Directors of the corporation in accordance with the provisions of the By-Laws of the corporation.

#### <u>ARTICLE V</u>

#### Terms of Existence

The term for which this corporation is to exist shall be perpetual.

#### **ARTICLE VI**

#### Officers

- A. The affairs of this corporation shall be managed by officers and composed of the following:
  - (1) Tampa Historical and Cultural Education Complex
  - (2) No less than four (4) adult persons elected by majority vote of the members of the corporation at a duly called meeting as provided in the By-Laws.

- B. The officers shall be elected annually by a majority vote of the Board of Directors and shall be a chairman, a vice chairman, a secretary and a treasurer and such other officers as may be provided for in the By-Laws of the corporation. The same person may hold multiple offices. The duties of the respective officers and the manner of filling vacancies in the offices of the corporation shall be provided in the By-Laws.
- C. The manner of filling vacancies on the Board of Directors shall be provided in the By-Laws of the corporation. A quorum for the transaction of business shall be a majority of the board qualified and active, and the act of a majority of the board present at a meeting at which a quorum is present shall be the act of the board. Meetings of the board may be held within or without the State of Florida.
- D. Officers of this corporation may be removed, with or without cause, by the members at a meeting duly called in the manner set out in the By-Laws.

#### **ARTICLE VII**

The name and address of the officers of this corporation who, subject to these Articles, and the By-Laws of this corporation and the laws of the State of Florida, shall hold office the first year of the existence of this corporation or until an election is held by the committee of this corporation for the election of permanent officers or until their successors have been duly elected and qualified are:

#### **ARTICLE VIII**

#### Initial Registered Office and Registered Agent

The name of the corporation's initial registered agent at the following address is Annette Jenkins, 303 Crayford Place Valrico, Florida 33594 and the street address of the corporation's initial registered office is 303 Crayford Place

Valrico, Florida 33595. The corporation shall keep the Department of State of the State of Florida informed of the current city, town, or village and street address of said registered office together with the name of the registered agent.

#### ARTICLE X

#### By-Laws

The By-Laws of this corporation may be made, altered, or rescinded from time to time in whole or in part by a majority vote of the trustees of this corporation present at any meeting of the Board of Directors at which a quorum is present and notice of the proposed action with respect to the By-Laws has been waived by a majority of the members of the Board of Directors or mailed by the secretary of this corporation to all of the members of the Board of Directors at least three (3) days before the meeting.

#### ARTICLE XI

#### Amendment of Article of Incorporation

The Board of Directors upon a majority vote of the Board may amend these Articles of Incorporation.

## ARTICLE XII Dedication Of Assets

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) and 170(e)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the Federal, State, or Local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

## ARTICLE XIII Indemnification

This corporation shall indemnify an Officer or Director or any former Officer or Director, to the full extent permitted by law.
