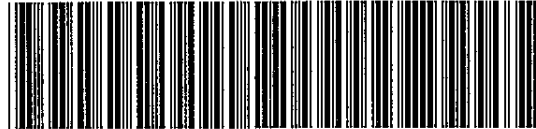

Dear Sirs,

My name is Donna C. Brown and I am the new registered agent for Stolen Child 911 Television Network Inc. located in Lakeland, Florida. I have been working diligently over the past (11) eleven months, since April of 2003 to rebuild the organization to what it is now becoming.

Mr. Diaz who was the past president did an excellent job and accomplished a great deal as to where the television show would have been released on National T.V. in January 2003. In November 2002 his newly-wed-wife had him incarcerated on false charges for her own personal gain in a lawsuit against "American Multi Cinema" theaters.

Mr. Diaz, whom all of the cast and crew knows is innocent, was warned by everyone not to marry the woman and to discontinue his relationship with her, but he insisted in using her as his co-star in many of the (39) thirty-nine television episodes.

Over the past year we have attempted to re-edit many of the scenes being that Mr. and Mrs. Diaz were the stars of "Stolen Child 911". Following their ugly separation and recent divorce the company, as well as myself, have suffered several losses from four burglaries and also had to move our editing suites from Wabash Avenue.

Mr. Diaz will work as a director and continue producing "Stolen Child 911" until his name has been cleared of the charges by the courts sometime in November of 2004. At that time Mr. Diaz could and very well may be reinstated as President of the organization.

Stolen Child 911 Television Network Inc. will continue its work in the prevention of child abduction and the assistance to victim parents of abducted children. Although the corporation has suffered several setbacks we feel that in the long run we will succeed.

It has also become necessary to reorganize the corporation and terminate those officers who did nothing to assist in rebuilding and restructuring the corporation. Due to the fact that no one draws any type salary many no longer wished to devote their time.
