ARTICLES OF INCORPORATION OF

GOSPEL ARENA INTERNATIONAL MINISTRIES INC.

ONE: The name and address of this principal corporation is Gospel Arena International Ministries, 613 NE 3rd Avenue, Fort Lauderdale, Florida, 33311. The corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for Religious purposes to establish structured support services for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the Corporation creed/bylaws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic and Social development Programs, but shall not be limited to: Homeless, Health care, Child Care, Youth at High Risk, Tutorial, Land Acquisition, Housing, Job Training, Job Placement, Counseling, Employment Marriage Ceremonies, Burial Services, Youth and Singles Activities Center, Bookstore, Conferences, Crusades, Revivals, Seminars, Drama (The Arts), Radio, Television, Tape, Video and Book Distribution, other programs to aid those in need and activities to uplift and build the body of Christ.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

All articles or amendments of the corporation shall be terminated, if at any time be in

conflict with the teachings of Jesus Christ. The above articles are in accordance with the 1st and 4th amendments of the U.S. Constitution.
