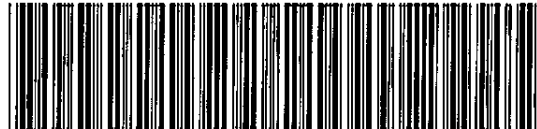

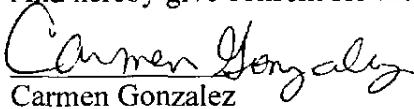

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

**NEW CORPORATE NAME -** Multicultural Resource Center and Multicultural Adult Center, Inc.

**AMENDMENTS ADOPTED-** Article III is being added:

This organization is a nonprofit corporation organized and operated exclusively for exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code.

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to, its member, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III thereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by:

- (1) A corporation exempt from Federal Income Tax under Section 501 (c)(3) of the IRS code of 1954 or any future tax code, or:
- (2) By a corporation, contributions to which are deductible under Section 170(c)(2) of the IRC of 1954 or any future IRS law.

The Board of Directors may cause the corporation to solicit, collect, receive, accumulate, administer and disburse funds in such manner as will, in the sole discretion of the Board of Directors, most effectively operate to further the purposes of the corporation.
